JAMES CHARLES KLEINKAUF Most Excellent Grand High Priest 2019

#### JAMES CHARLES KLEINKAUF

James Charles Kleinkauf was born in New Haven, Connecticut and has lived in Guilford, Connecticut all his life. Growing up on the shoreline, James has always had a strong love for Long Island Sound. He was a member of the Guilford Sea Scouts and participated in the annual Memorial Day wreath ceremonies and became an Assistant Sea Scout Master. James built motorized bicycles and go-carts in between studying, fishing and running his own lawn mowing business. After graduating from Guilford Senior High School in 1961, James became a machinist foreman at the George Schmidt Company in Guilford before deciding to apprentice to Al Offredi, master plumber of Offredi Plumbing and Heating. During that time, he took over as the Sea Scout Master to train Guilford youths in Seamanship.

He married Suzanne V. Kawra, his high school sweetheart, in 1963 and started his journeymanship of plumbing with James Collopy, Collopy Plumbing and Heating of Branford. During this time, he went to Eli Whitney Technical School to further his education and received a certificate at the end of his studies. In 1970, James' and Suzanne's daughter Jamie Sue was born, and James finished his Master Plumbing training with Frank D'Amico of D'Amico Plumbing and Heating in Branford and received his P 1 license from the State of Connecticut. An avid outdoorsman, James enjoys hunting, fishing, boating and riding motorcycles. In 1973, he started his own business, "James C. Kleinkauf, Plumbing & Heating" in Guilford and is still working at his craft in 2019.

James became a member of the Guilford Jaycee's in 1977. As a member of the Guilford chapter of the Jaycees, James assisted with the annual Christmas party for underprivileged children. He was an integral part of the restoration of the buildings and fences at Jacobs Beach in Guilford. James trained youths on gun safety and BB gun shooter education, regarding the correct way to handle firearms. During his three year civic tenure, James won many recognitions including the Sparkplug award, Jaycee of the Year Award for 1979, and the John H. Armbruster "Keyman Award".

James formed the Masons Knights Brothers II Club to raise money for the hearing-handicapped Guilford residents. He organized the annual "Haunted Hall" as a safe Halloween activity for local youths.

James was a member of Guilford Community Television (GCTV) and served on the Board of Directors for three years. He volunteered and filmed Guilford Town Meetings for the Boards of Selectman, Finance, and Education, as well as Planning & Zoning meetings and town elections. James trained members and the public on how to use the equipment as well as maintaining the equipment and scheduling rentals.

James was a member of the Guilford Harbor Management Commission for eight years and also served on the Guilford Marina Commission for eight years. James joined St. Alban's Lodge #38 AF & AM in 1975, Halleck Chapter # 44 in 1977, Eastern Star in 1981, Crawford Council # 19 and also New Haven Commandery # 2 in 1982. He served as Treasurer for both Halleck Chapter and Menunketuck Council for twelve consecutive years. He is a member and past president of St. Albans Fellowcraft club and Guilford Temple Associations. As Master of St. Albans Lodge in 1982, he received the Master Achievement Award. When his daughter, Jamie, was in The International Order of Rainbow for girls, he was the Tyler for the Guilford Chapter. Jamie became Worthy Advisor and Grand Faith for the State of Connecticut, and James received the Grand Cross of Color with her in 1986.

James joined Menunketuck Council # 36 as a charter member in 1985 and served as Thrice Illustrious Master for Menunketuck Council #36 in 2003, 2004, 2009, 2013 and 2014. He is a member of the Council of Anointed Kings of Connecticut. In 2006, he was appointed Grand Conductor by Most Puissant Grand Master Peter J. Stapleton. In 2007 he received the Knight of Ish Sodi award. James was elected and served as the Most Puissant Grand Master in 2010. In 2016, he was presented with the Phillip J. Jones Distinguished Service Award by Most Puissant Grand Master Michael E. Seamon.

James served as High Priest for Halleck Chapter #44 Royal Arch Masons from 2001-2002 and 2010. In 2013 he was appointed to the Grand Chapter of Royal Arch Masons of Connecticut as the Grand Master of the First Veil by Most Excellent Grand High Priest David C. Abrames. He was accepted as the Grand Representative to the State of Pennsylvania. He also served on the York-Rite Coordinating Committee from 2006-2010. In 2019, he was elected Most Excellent Grand High Priest of the Grand Chapter of Royal Arch Masons of Connecticut.

James has been a member of Connecticut York Rite College #17 since 2008, and in 2015 he received the Order of the Purple Cross from the York Rite Sovereign College of North America. In 2015, he was elected Pre-Eminent Governor of the York Rite College #17. He is also a member of Mohawk Council #28, Knight Masons; Nathan Hale Council #78 A.M.D.; and Connecticut College, Societas Rosicruciana in Civitatibus Foederatis. He is a life member of the Masonic Veteran Association of Connecticut.

James is a member of Ancient Accepted Scottish Rite, Northern Masonic Jurisdiction, USA, in the Valley of New Haven and Lafayette Consistory of Bridgeport, and received in 2015 the Meritorious Service Award. He served on the Program Committee as Chairman for the Scottish Rite Family Life Diversity and arranged for the annual winter and summer picnics and social events from 2011-2019.

MEGHP James C. Kleinkauf extended a most cordial welcome to all companions in virtual attendance and acknowledged the presence of the following:

I would also like to recognize and thank Michael E. Sabia Jr., for getting us up and running on Facebook. His efforts have now allowed members and potential members to see the good work that we do, the awards that have been presented and announcements for Grand Chapter.

My theme this year was "Communication is Key." I tried to keep my slate of Officers in the "loop" as to what my plans were. We have to better communicate with all our Companions and to keep our minds open to new technology and the world around us.

## **GRAND SECRETARY**

I am pleased and privileged to offer the twelfth and FINAL report of my second tour of duty as your Grand Secretary. My special thanks to the Secretaries of the Constituent Chapters for their cooperation and prompt response to my requests for information and their assistance. With one or two exceptions, the monthly reporting from the Constituent Chapters continues to improve, and I commend the Secretaries for a job well done, and getting the reports to me in a timely manner. My special thanks to Lady Muff who continues to support me in all my endeavors. My thanks also to Assistant Grand Secretary William L. Miller II, without whom this year I would be totally lost. During my infirmity, he has stepped up and filled in for me, carted me to meetings, and generally has been a true friend and Companion. In addition, Companion James S. McNeely, Assistant Grand Secretary, has also stepped up to ease the burden by taking on the publication of "Opportunities". As I "retire", I want to say that this has been truly a "labor of love". I have immensely enjoyed serving as your Grand Secretary, but age is becoming a larger problem nowadays.

During the fiscal year ending 30 April 2019, I received and turned over to the Grand Treasurer the sum of \$33,947.27, including \$8,000 from the Grand Trustees.

Most of the Grand Secretaries of other Grand Chapters received the Proceedings via email, as did Grand Chapter Officers, Past Grand High Priests, Constituent Chapter High Priests and Secretaries for whom we had an email address. A few printed copies were prepared and sent to those known not to have computers and to the several libraries who maintain copies. A copy is also posted on our ctyorkrite.org website.

With three exceptions, all of our now 14 Constituent Chapters have submitted their Annual Returns, mostly on time. Hiram 01, Trinity 09, and Pulaski 26 have not yet submitted Annual Returns, though efforts are underway in each to correct this deficiency. Joseph Andrews Chapter No. 46 and Pulaski Chapter No. 26 entered into successful negotiations to consolidate with each other with the blessing of MEGHP Kleinkauf. It will now be known as Joseph Andrews / Pulaski Chapter No. 26.

The membership summary which follows shows the previous nine years, plus the current year, for comparison purposes. As you can see, we have had a steady decline over that ten year period, and it is obvious that we continue to lose members. Only Franklin 02 showed a net gain (1); while three: Trinity 09, Columbia 31, and Halleck 44 managed to stay even. Exaltations continue to be low, not even keeping up with the number of deceased, and also with large numbers of dimits and NPD. We suffered a net loss of 54, about the same as the last few years.

Of our 981 members, 16 are dual members, 132 are Fifty Year members or are in the care of Masonicare or other similar institution. Our per capita tax base is now only 833, (a net loss of 59). Overall, it was again not a good year for membership.

#### **GRAND TRUSTEES**

The Combined Trust Portfolio of the Grand Chapter is invested with RBC Wealth Management through our financial advisor, Mr. Dennis Stanek. RBC has been extremely diligent during these difficult market times and has provided monthly statements and weekly updates on our investments and market trends.

The starting balance of the portfolio on April 30, 2019 was \$719,036.02. During the last year, due to volatility in the market, we have continued to re-allocate our investments at the recommendation of our portfolio manager. These market fluctuations and re-investments resulted in an ending balance of \$716,883.73. We managed not to lose too much ground in our investment, even after taking a distribution of \$8,000.00.

The physical inventory and properties of the Grand Chapter are in the custody of the Grand Secretary, the Grand Officers (aprons and jewels), and the Past Grand High Priests (jewels). Aprons, Officers' Jewels, and Past Grand High Priests' Jewels are the property of the Grand Chapter and are to be returned to the Grand Secretary when the term of office has expired or upon the companion's passing.

#### **GRAND CAPTAIN OF THE HOST**

This year Captiular Masonry in Connecticut has been unique. It started off with great energy at the June Grand Session when Most Excellent Grand High Priest James Kleinkauf expressed great expectations for his programs and his desire to rebuild the struggling Chapters. However, December was fraught with meeting cancellations due to weather and in March the COVID-19 Virus Pandemic brought Connecticut Freemasonry to a screeching halt. We have just been informed that the Grand Chapter Session in June will be held as a virtual teleconferencing meeting. At the moment of this writing (April 26<sup>th</sup>) future Masonic activities are much in doubt. This makes it a little difficult to write this report.

A few years ago our Most Excellent Grand High Priest modified the Chapter inspection protocol by deciding that the Grand Veils and the Grand Royal Arch Captain would each be assigned either three or four Chapters to inspect and that the Grand Captain of the Host and Grand Principal Sojourner would oversee and act as mentors to these Companions. This year I was assigned to mentor Right Excellent Companion Mychael Scribner, who was assigned to inspect Union 7, Trinity 9 and Halleck 44 and Right Excellent Companion Russell Scull who was assigned to inspect Franklin 2 (my Chapter), Burning Bush-Washington 6, Pulaski 26 and Keystone 27. Four of these Chapters conflict with my other Masonic bodies. I was able to accompany Companion Scribner on a visit to Trinity 9 for their inspection and was going with him to Halleck 44, but that meeting was cancelled. I accompanied Companion Scull on his inspection visit to Franklin 2 but had conflicts with the other three Chapters. I have to admit that I was not too effective in mentoring these two Companions.

#### **Out of State Visitations**

This year I was only able to attend the Grand Chapter Sessions in Vermont, Massachusetts and New Jersey. I had planned to attend the Delaware, Maine and New Hampshire Sessions but they were cancelled due to the COVID-19 Pandemic. I will try and participate in the June teleconference session being held by the New Hampshire York Rite. Family commitments prevented me from attending the New York, Pennsylvania and Maryland Grand Sessions. Another out of state visitation I was able to attend was to the September Grand Encampment's Northeast Department Conference, where the Friday program was a combined presentation by the General Grand Chapter and the General Grand Council. For once this program was informative without the "same old-same old".

#### **Inspections**

I was present for the inspection of three Chapters: Franklin 2, Trinity 9, and Cyrus-Meridian 15, and took parts in the portrayal of the ritual in them.

#### **Fraternal Visitations**

There are five Royal Arch Chapters (Hiram 1, Burning Bush-Washington 6, Rittenhouse 11, Keystone 27, and Joseph Andrews 46) which meet on the same night as my own Chapter, Council or Eastern Star Chapter, which makes it hard for me to schedule visits to them. While it is my goal this year to attend at least one Stated Convocation of each of the fifteen Chapters in Connecticut, I was only able to visit seven of them plus my two home Chapters.

<u>Hiram</u> <u>1</u> – I could not make a visit to his Chapter, however they brought a candidate to Cyrus-Meridian 15 for degree work. It is my feeling that this Chapter will not last much longer, and probably will soon be consolidating with Cyrus-Meridian 15 in Torrington.

<u>Franklin 2</u> – This is almost the same observation as last year, because nothing has really changed. This is my primary Chapter, and we were only

able to open eight Stated Convocations. However the Chapter was still able to do their own ritual work and exalted four new Companions, but it is still a struggle to get nine Companions present to open the Chapter. Two of the new Companions have agreed to take offices in the Chapter this year and there are a few candidates in waiting for the degrees, so there may be success in the future for this Chapter.

**<u>Burning</u>** <u>Bush-Washington</u>  $\underline{6}$  – No visits. Conflicts with Harmony Council 8.

<u>Union</u>  $\underline{7}$  – A conflict with my Lodge meetings prevented me from visiting this Chapter.

<u>**Trinity 9**</u> I visited this Chapter with Companion Scribner in October for their inspection. Unfortunately they did not have enough of their Companions present to perform a degree on their own, but with assistance from Companions from Union 7, they were able to confer the work. Recently these two Chapters have been working together, and although I doubt they would ever actually consider consolidating, this coordination of effort appears to be keeping both Chapters in business. The loss of Right Excellent Companion Gary Littlefield has impacted the progress of this Chapter.

**Rittenhouse 11** – No visits. Conflict with Cyrus-Meridian 15 meetings.

**Housatonic** 13 - I was able to visit this Chapter in July for a conferral of the Royal Arch Degree. It was well done, and I am pleased to report that the consolidation of Jerusalem 13 and Milford 49 appears to be successful.

**Cyrus-Meridian** <u>15</u> – This is my other Chapter, and I can report that this Chapter was able to open all but three Stated Convocations and exalted two new Companions. Three other Companions are waiting for the Royal Arch Degree. It is pleasing to note that two of the new Companions will be officers this year, and two of them that are waiting to finish their degrees have also shown interest to be future officers.

**Pythagoras** <u>17</u> – I visited this Chapter twice, the second time to witness the Royal Arch Degree. Their officer corps had a mix of veteran Companions and new members. The work was excellent, and this Chapter appears to be in good shape.

<u>Pulaski</u> <u>26</u> – I attended one Stated Convocation of this Chapter. The Chapter is struggling to have a quorum present to open meetings and conferring degrees. The Chapter has entered into a discussion with Joseph Andrews 46 regarding consolidation of the two Chapters.

<u>Keystone</u> 27 – No visits. Conflict with Franklin 2. I tried to convince both Chapters, with no success, that a yearly combined Chapter meeting would be beneficial to both. This is one of the reasons that the New Haven Chapter and Council switched their meeting nights to line up with the Meriden bodies.

<u>Washington</u> <u>30</u> – I visited this Chapter in September to assist them in conferring the Most Excellent Master Degree. The continued improvement of this Chapter is due to the efforts of several Companions who have

worked hard to overcome their problems of the past. Continued improvement is expected in the future.

<u>Columbia</u> <u>31</u> – I visited this Chapter in June, and they brought candidates to Cyrus-Meridian 15 for a Most Excellent Master Degree. I had planned to attend their annual corned beef dinner in March but it had to be cancelled because of the virus. That was disappointing because that night Reverend Tim Squire was going to present a program on his recent Grand Encampment Pilgrimage to the Holy Land. While the same officers continue to hold the chairs, they have new candidates this year, and hopefully they will become active in continuing the good work of the Chapter.

<u>Halleck 44</u> – I visited this Chapter in June and had planned to visit a couple of other times, but was informed that there would not be enough Companions present to open. Later in the year this Chapter began meeting by dispensation of the Grand High Priest with Pulaski 26 in Branford. Consolidation with another Chapter would be good for this Chapter, and committees have been appointed in both Franklin 2 and Halleck 44 to discuss such a merger.

<u>Joseph</u> <u>Andrews</u> <u>Chapter</u> <u>46</u> – No visits. Conflict with Cyrus-Meridian 15.

My observations are also nearly the same as last year and indicate to me that the major concern for Capitular Masonry in Connecticut is the need to convince the younger Companions to become active participants in the Chapters. This appears to be a concern for most of the Chapters. I am not sure how to proceed with solving this problem, but it certainly needs to be addressed soon.

With regards to the four Chapters along the shoreline, it now appears that the immediate result will probably be a consolidation of Pulaski 26 and Joseph Andrews 46 into one Chapter and possibly Franklin 2 and Halleck 44 into another. I still believe the best solution for this situation is the four Chapters forming into one, but this does not appear to be happening in the near future.

#### **GRAND ROYAL ARCH CAPTAIN**

This has been quite an unprecedented year. With the closing down of Masonic meetings due to the COVID-19 Pandemic, I was unable to do the necessary inspections with my assigned Chapters, partly due to my usual planning to inspect them in the spring time, after I had assessed their general activities and have seen their welfare as a Chapter. I did make visits to my assigned Chapters, and will make my assessments below:

#### Hiram #1

Hiram Chapter has had several hiccups over the last several years. Based on what I have seen, this seems to be based on the overall health of the Lodge it is attached to, Hiram #18. While the HP is a great Companion, I do see that the Chapter has been unable to have a line of officers behind him to continue their work, and has been given dispensation well beyond the allowed 2 consecutive term limit in the Grand Chapter regulations. There are two paths I see for Hiram Chapter: either they seek to merge with

a viable Chapter nearby, perhaps where their Companions are members of Council and Commandery (i.e. Stratford); or they completely overhaul their communications, their work, and tighten the ole' belt to grow membership, which is an extremely difficult route (but can be done with the right people involved). I made 2 visitations to Hiram #1 this year, Wednesday June 12, 2019, which they were able to open; and Wednesday January 8, 2020, in which I accompanied our ME Grand High Priest, and which unfortunately they were unable to open.

#### Rittenhouse #11

Rittenhouse Chapter has had many successes over the past several years contingent with its implementation of a two-year degree program together with the Council and Commandery in Norwalk. Every meeting has a purpose, with meaningful discussions, and I foresee with some tweaking, there can be room for more improvement as they grow. Some areas to address may be stagnation in growth, however there are advantages to slowing down the numbers entering as a two-year program does weed out "tourists" and encourages those for a deeper love of education and the craft to join its ranks. As a member, I am generally in attendance unless I have an emergency.

#### Housatonic #13

Housatonic Chapter is one of the rising stars, with large, new classes beginning semi-annually. The merger between Stratford and Milford has shown the potential that can build when two groups of Bodies combine for a greater purpose. As an officer in the Chapter, I have been on hand to assist where needed to the growth of this group. I have also noted that the Companions agree that the one need to improve upon will be the necessity of meeting more often, as they currently only meet 5 times per annum.

#### **Joseph Andrews #46**

I was only able to make one appearance to Joseph Andrews Chapter on Thursday September 12, 2019, due to the Chapter Degree Schedule at my home Chapter in Norwalk meeting the same nights. This occasion was their Awards night, which had a great turnout, and with the upcoming merger with Pulaski #26, I believe they have a fighting chance to grow, perhaps as seen in the Stratford-Milford merger a few years ago. Only time and work on the part of its leadership will tell.

#### **Other Visitations**

Due to the COVID-19 Pandemic, there will be no Anointed High Priest Degree this year as of this writing. This is unfortunate, but due to the circumstances, a necessary measure to prevent its spread. I made no visitations outside of this jurisdiction, but plan to if appointed to continue in the line next year. I wish to thank everyone who I have had the pleasure to work with this year, and am thankful for the experiences I have learned as an appointed officer of the Grand Chapter. I look forward to what the years bring and have been much honored to serve as Grand Royal Arch Captain. I especially wish to thank ME Companion James Kleinkauf for appointing me to this position.

There is a clear desire to build the chapter active membership and plans were discussed to do so.

A subsequent visit was not possible due to the pandemic restrictions.

#### **COLUMBIA Chapter #31**

Reached out to the High Priest and Secretary after the summer break to arrange for an informal visit followed by a formal visit / inspection at a future date of their choosing. Received a response and an informal visit was scheduled for Oct  $4^{th}$ .

On the October 4<sup>th</sup> visit, was able to meet a handful of the Companions and enjoy a good evening of fellowship and pizza. Although there were not enough Companions present to open, it was apparent there was a great spirit of friendship and brotherly love among the Craft.

Reached out to the High Priest and Secretary after the holidays to arrange for a formal visit / inspection at date of their choosing. Received a response that there were no candidates in the works and degree was not planned. Scheduled to attend the annual meeting in April which was subsequently cancelled due to the pandemic restrictions.

In summary, the Covid-19 Pandemic cut the year short and curtailed much activity for the fraternity (and the world). Despite the unprecedented circumstances, it was a sincere pleasure meeting the Officers and Companions of these Chapters. Although I was only able to formally inspect one of the four chapters assigned, all four chapters exhibited great Brotherly love and friendship. Like so many chapters throughout the state, three of my assigned chapters are in need of: 1) increased active membership in order to consistently open chapter; 2) building an officer corps with proficient ritual for opening and closing; 3) creating a reliable and continuous feeder system (through relationships with Blue Lodges) to initiate new members, and; 4) retaining an active membership through quality degree ritual and engaging and creative fellowship activities.

### **Budget Resolutions**

The Grand Chapter hereby appropriates from the General Funds the sum of \$29,000 for operations for the fiscal year ending 30 April 2021 as presented in the Budget.

The following assessment is levied upon each Constituent Chapter based upon the members on the rolls of the chapter on 31 March 2021, which sum shall be paid to the Grand Chapter with the annual returns due on or before 30 April 2021:

Per Capita Tax - \$18.00 for each member on the rolls with exception of those exempt per Sections 109 and 305 of the Law (MHC, 50 year members, and dual members). This includes the subscription to the Royal Arch Mason Magazine and the former assessment for liability and general insurance coverage. (Each individual Chapter is responsible for insurance for their property, paraphernalia, etc.) **This is no increase.** 

The Grand Treasurer is authorized after 30 April 2021 to expend funds at the same rate as in this budget until the budget for the next fiscal year shall have been approved.

The amount designated in the budget as Grand High Priest Travel Reimbursement is intended for reimbursement to the Grand High Priest to offset the cost of visiting Annual Convocations of Grand Chapters in the Northeastern United States and Eastern Canada, as well as the Northeastern York Rite Conference and the General Grand Chapter Triennial. Receipts or other supporting data must be presented to the Grand Secretary to obtain reimbursement. Mileage reimbursement shall be at the rate of \$0.57 per mile for out of state travel for automobile travel, plus tolls and parking.

#### **COMMITTEE ON INSURANCE**

Our General Liability policy providing coverage for the York Rite bodies of CT has been written for a number of years by New Hampshire Insurance Company (an AIG company). There is a primary policy with a \$1,000,000 limit of liability with an excess policy providing an additional \$1,000,000. The non-owned auto coverage provides \$1,000,000 excess of the vehicle owner's underlying policy. Coverage for damage to rented locations such as Masonic Temple Corporations is \$300,000. Medical payment coverage is limited to \$10,000 per person. Our insurance agency, A. F. S. & V., and agent Dorry Watkins, have been monitoring our insurance needs for many years and she has worked to keep us up to date on any required changes, subject to the realities of the insurance market place. She has indicated that they do not have access to other insurers willing to write the coverage.

The premium charged for this single policy is apportioned between the Grand bodies based on membership at the beginning of the policy year. Grand Chapter pays the entire premium and is reimbursed by Grand Council and Grand Commandery. This appears to be an equitable basis for premium sharing as the cost of insurance protection/coverage should reflect the total involved time of individual Companions and Sir Knights. The annual premium may be adjusted slightly (both up and down) as total membership numbers change, thus reflecting changes in membership.

At our request, two years ago we changed the annual renewal date of the coverage. This change makes the provision of current membership numbers of the three bodies easier to arrive at and thus the premium sharing and calculation more timely. The new renewal date became May 24 as a result.

Less than one week prior to May 24, 2019, the renewal date, we were informed of the new premium for the coming year. In spite of an approximate 12% reduction in the total number of members (the basis for premium calculation) our premium increased nearly 13% over the prior period. This was tantamount to a 25% increase in our rates. As there was not time left to market the offering, we had to accept it. The annual premium became \$6,585.

The quote from AIG for the 2020 renewal is \$7,600, another increase of 18 %!

In consequence of last year's increase, the committee began late in 2019 to evaluate options. For this purpose, we have been working with the Auburn Insurance Agency (AIA) in Massachusetts. They specialize in handling various Masonic programs. Their market of choice for this type of policy at the moment is the Philadelphia Insurance Company (PIC) which seems to be gaining headway writing Masonic business. They also work with other agencies but PIC is not free with information as to who they are.

AIA has a proprietary set of endorsements with the PIC for Masonic business. This sets them apart from anyone else placing Masonic business with PIC or other companies. In addition, as of late, we have been informed that there have been a number of companies which have decided to exit the fraternal business and the AIA has been picking up additional accounts as a result.

We received a proposal from the PIC. The PIC currently insures the York Rite bodies of Massachusetts and Maine on a basis similar to that proposed. In addition, they handle the Grand Lodge of Connecticut, the CT constituent Lodge Masonic Temple Corporations (which choose to have them do so) and the York Masons Hall Corporation in East Hartford.

The PIC proposal has comparable and sometimes greater limits than the AIG policies which are due to expire on May 24. The proposal also includes "Crime" coverage - a coverage which we currently do not have. [Commercial Crime coverage is designed to meet the needs of organizations other than financial institutions (such as banks). A commercial crime policy typically provides several different types of crime coverage; such as: employee dishonesty coverage; forgery or alteration coverage; computer fraud coverage; funds transfer fraud coverage; kidnap, ransom, or extortion coverage; money and securities coverage; and money orders and counterfeit money coverage.] The proposal also includes Liquor Liability for Masonic events provided Connecticut State regulations and licensing laws are observed.

The PIC proposal is for an annual premium of \$6,284 - a little less than that of the expiring policy. Your committee, following review with the three York Rite body presiding officers, has accepted their proposal.

#### **D&O and EPLI**

In addition, your committee, working with the AIA, has been looking into the purchase of Directors & Officers (D&O) insurance coverage for each of the three Bodies. This type coverage, written by the Great American Insurance Company (GA), is for the purpose of protecting those serving in executive positions (i.e. Line Officers) in each Grand York Rite body from any lawsuits filed against them for "alleged injury" arising out the performance of their duties. It also provides coverage for the respective Grand Body Corporations. Without such insurance, the personal assets of those serving as officers are at risk.

While officers and directors of not-for-profit entities are exempt from liability under both state and federal law, in our litigious society, this would not prevent a party from alleging injury and filing suit. Until a court of competent jurisdiction makes a ruling on the applicability of the exemption laws, or if the court decides that the exemption does not apply to the case under consideration, there are legal expenses to be paid. This insurance provides coverage for those legal expenses.

For this kind of coverage, each of the Bodies must make their own decision and purchase their own policy. The premiums quoted for these limits are as follows:

If it can be budgeted, the committee recommends each of the Grand Bodies consider purchasing this coverage with a \$1,000 deductible to protect those who serve as Grand Officers (or Directors).

We have determined that it is not possible to include constituent units in the Grand Body policies. It would be necessary that they be individually purchased. If any of them are interested in such coverage, they should let the committee know so that we can make the appropriate inquiries. Be aware that it is likely that the minimum premium for issuing any policy for this coverage will be about \$500.

#### **COMMITTEE ON JURISPRUDENCE**

The Committee has reviewed the Address of the Most Excellent Grand High Priest, Companion James C. Kleinkauf, and recommends its publication in the Proceedings of the 222<sup>nd</sup> Annual Convocation of the Most Excellent Grand Chapter of Connecticut.

The dispensations issued by the Most Excellent Grand High Priest have been reviewed and are consistent with Grand Chapter law and practice. Additionally, the decisions of the Grand High Priest are also in order and are approved.

Additionally, we have reviewed the reports and recommendations of the subordinate Grand Chapter Officers and refer them to the incoming Most Excellent Grand High Priest. They offer an excellent insight into the condition of the constituent Chapters and point out where additional efforts are needed to promote and maintain the Capitular Rite in Connecticut.

#### **Proposed Changes to the Constitution and Law**

The Committee has not received any proposed changes to either the Constitution or Law, and there is no pending legislation carried over from last year.

As some members of this Committee also serve on the Grand Council Jurisprudence Committee, we recommend to both the incoming Most Puissant Grand Master and the incoming Grand High Priest that the two Committees work together in an effort to standardize the Constitution and Law of both Grand Bodies where possible.

We recognize that there are specific requirements for each body that may not be needed in the other, but it is our belief that the similarities are much more. This would require potentially renumbering of sections and some verbiage changes, including perhaps showing a section as unused in one body so as to keep the other numbers matched.

Should this recommendation be adopted, both Committees would present to their respective Grand Body a rewritten Constitution and Law at the next Annual Session which will then lay over for one year prior to voting for approval.

#### **Committee Report Summary**

The observations of the Most Excellent Grand High Priest regarding the constituent Chapters and his thoughtful recommendations are sincerely appreciated and deserve careful consideration by his successor. We also commend him for his diligence in assisting and facilitating the merger of Chapters to strengthen our Grand Chapter. This committee commends the Most Excellent Grand High Priest, Companion James C. Kleinkauf, for his exemplary service and tireless dedication to the Grand Chapter of Connecticut and the manner in which he has represented the Grand Chapter both within and outside of our jurisdiction.

#### **COMMITTEE ON RITUAL**

At the June 1<sup>st</sup> Annual Convocation of the Grand Chapter of Connecticut, legislation was voted upon to change the titles of four of the subordinate chapter officers by remove the honorifics "Most" and "Grand" from their titles. This change would eliminate the confusion between grand and subordinate chapter officer titles and bring them more in line with common Masonic usage. The recommendation was to change the title of "Most Excellent High Priest" to "Excellent High Priest", retain the titles of "Excellent King" and Excellent Scribe" and to remove "Grand " from the titles of the three Veils making them "Master of the First Veil," etc. This change was approved by a majority vote of the Companions present at the Annual Convocation.

Subsequently, at the request of the Grand Secretary the Ritual Committee was asked to review the revised text of the standard ritual to see that these changes were properly made. Upon said review the Ritual Committee approved the changes and the next edition (2<sup>nd</sup> Printing) of the Standard Work - 2018 ritual was printed and distributed.

Standard Work - 2018 ritual was printed and distributed. Later in the year the Grand Secretary requested permission from the Ritual Committee to print the next edition (3<sup>rd</sup> Printing) of the Ritual. Since there were no additional changes in the ritual to be reviewed the Committee approved this request.

The latest and current edition of the approved ritual is the Standard Works -2018 (3rd Printing) edition. At present it does not appear that there is any future need to change or modify this ritual.

#### GENERAL GRAND CHAPTER DISTINGUISHED SERVICE MEDAL IN GOLD

The General Grand Chapter Distinguished Service Medal in Gold is presented by the General Grand Chapter for extraordinary Masonic achievement and/or national or international achievement in the Arts and Sciences, in Public Service, or in Business and the Learned Professions. Not more than one medal may be presented each year.

The only Connecticut recipient of this highest of honors was Companion James R. Case (9), now deceased, who received the medal in 1988.

#### GENERAL GRAND CHAPTER DISTINGUISHED SERVICE MEDAL IN SILVER

The General Grand Chapter Distinguished Service Medal in Silver is presented for exceptional Masonic achievement; the performance of outstanding service for the York Rite, but particularly for Royal Arch Masonry. Nominations may be made by the Grand High Priest and forwarded by the D.G.G.H.P. and by him to the General Grand High Priest. Nominations shall be accompanied by a resume of the Royal Arch Service of the proposed recipient and a brief biographical statement. Three nominations may be made during a Triennium from each jurisdiction, but only one will be presented during each Triennium to a Royal Arch Mason of one of the affiliated Grand Jurisdictions of each York Rite Region. Not More than three such Silver Medals also may be presented at the Triennial Convocation from selection at large.

Only two Connecticut Companions have been recipients of this very high honor:

Companion Richard L. Smail (18,27), now deceased, who received the medal in 1991.

Companion Charles B. Fowler, Jr. (17), who received the medal in 2011.

#### **GENERAL GRAND CHAPTER** DISTINGUISHED SERVICE MEDAL IN BRONZE

The General Grand Chapter Distinguished Service Medal in Bronze is presented to a Royal Arch Mason for meritorious service to Royal Arch Masonry other than holding Masonic Office as a Past Grand High Priest or as a Grand Chapter Officer. Only one such medal may be presented each year in each jurisdiction affiliated with the General Grand Chapter. The recipient is selected each year by the Grand High Priest of the jurisdiction.

#### WILLIAM LINDSEY MILLER, II

#### General Grand Chapter RAM Intl Medal in Bronze

Companion William Lindsey Miller, II is a native of Wheeling, West Virginia where he was born on July 11, 1948, the elder son of Margaret Dull and Robert Lindsey Miller. Bill received his early schooling at Linsly Military Institute, graduating in 1966, followed by engineering studies at Rensselaer Polytechnic Institute, culminating in a Master of Science degree in Chemical Engineering in 1971, whereupon he was commissioned an officer in the U. S. Naval Reserve. For his active duty assignment, Bill served on the personal engineering staff of Admiral Hyman G. Rickover in the Navy nuclear propulsion program. After completing his Naval tour, he relocated with his family to Windsor CT in 1975 to start a long career with Combustion Engineering (followed by ABB and Westinghouse) in the field of commercial nuclear power plant design and construction, and nuclear plant international sales and marketing. Bill retired from Westinghouse in May 2012.

In Windsor, Bill became active in Grace Episcopal Church, the choir and the Vestry, and launched into community service by joining the local Lions Club. He held all club positions and served as a 100% Club President twice, in 1980 and again in 1990. He became active state-wide as well, serving on numerous cabinet level positions in Lions District 23B including Deputy District Governor, earning many service awards. He continues to be active with the Windsor club and is currently Treasurer.

Bill's children include daughter Stephanie, a graduate in nursing from Sacred Heart and Fairfield Universities, and sons Robert and James, both residing in Georgia with their families and Bill's three granddaughters Lindsey, Cierra, and Sarah. Bill resides in East Granby.

Brother Miller was raised a Master Mason in Washington Lodge No. 70 in Windsor on November 14, 1983 and became active as an officer. His career schedule at the time did not permit him to continue in the Lodge line, but he was nonetheless active. He is the founding editor of the Lodge's well-known newsletter, the *Washington Wayfarer*.

Companion Miller was exalted in Pythagoras-Welles Chapter No. 17 on September 21, 1985 and again promptly went to work as an officer, culminating in his advancement to the office of High Priest in 1988. He commenced his service as Secretary of the Chapter in 1990. After organizing the historical records from the prior merger of three Chapters, he assisted in the next merger with Delta Chapter No. 51 in 2000, re-forming Pythagoras Chapter No. 17 leading to its 200<sup>th</sup> Anniversary Celebration in 2016. He continues as Secretary and conservator of the Chapters' records and Royal Arch Widows degree for special occasions.

Bill also became active in the Grand Chapter, first as editor of the Connecticut section of the "Royal Arch Mason Magazine" for three years, and receiving an appointment as the Representative of the Grand Chapter of Queensland in Australia. He served for five years as Chairman of the Grand Custodians, coordinating training sessions and Custodian inspections. In 2004, Bill was appointed to the Grand Chapter officer line by Most Excellent Grand High Priest Robert G. Fitzgerald and in regular fashion ascended to service as MEGHP in 2012. Also in 2004, Bill was Most Excellent President of the Connecticut Convention of Anointed High Priests in Royal Arch Masonry, followed by present service as Treasurer-Recorder. Bill's service to Capitular Masonry was recognized in 1995 with the Ephraim Kirby Citation.

Companion Bill was received and greeted in Wolcott Council No. 1, Royal & Select Masters on October 26, 1985 and served as Thrice Illustrious Master in 1993 and again in 1997. He is presently a Trustee and is also a member of the Connecticut Council of Anointed Kings. He received the Ish Sodi Award for service to Cryptic Masonry by the Grand Council in 2009.

Sir Knight Miller was knighted in Washington Commandery No. 1, Knights Templar on November 16, 1985, and in 1992 was installed as Eminent Commander, and again in 1996. He was General Chairman for the Commandery's celebration of its 200<sup>th</sup> Anniversary in 1998. He continues to serve as a Trustee, Armorer and Director of the Order of Malta.

Bill's service to the Grand Commandery began in 1994 when he was appointed Editor of the Connecticut Supplement of the *Knight Templar Magazine*. He was appointed to the officer line of the Grand Commandery in 1997 by Right Eminent Grand Commander Charles B. Fowler Jr. He was appointed in 2003 as Representative of the Grand Commandery of his home state, West Virginia and in 2005 received the prestigious Knight Commander of the Temple award from the Grand Encampment. Bill completed his journey through the line and in 2006 was elected and installed as Right Eminent Grand Commander. Bill continues to serve as Chairman of the Holy Land

Pilgrimage program of the Grand Commandery, and as Chairman of the Connecticut Knights Templar Educational Foundatiion.

SK Bill has also been active in a number of the other Masonic appendant bodies to which he currently belongs. He served as Sovereign Master of Nathan Hale Council No. 78 of the Allied Masonic Degrees in 2000, and in 2004 he was appointed by Supreme Magus Thurman C. Pace to be Chief Adept of Connecticut College of the Masonic Rosicrucians, in which capacity he continues to serve. He was appointed by Supreme Magus William Koon to the office of Second Herald of the SRICF High Council. He served on several degree teams for the Valley of Hartford of the Scottish Rite. He is a Past Prior of Apostles Tabernacle XXVII of Holy Royal Arch Knights Templar Priests.

Other affiliations include Connecticut York Rite College No. 17; Nutmeg Chapel No.29, St. Thomas of Acon; Good Intent Chapter No. 17 and Ionic Chapter No. 100 of the Order of Eastern Star; Westwood Court No. 5 of the Order of Amaranth; Mohawk Council No. 28 of Knight Masons; the Masonic Veteran Association; and Sphinx Shriners. And among many memorable events, in 2014, Bill received the James Royal Case Award for service to the York Rite in a surprise ceremony he was conducting !

#### EPHRAIM KIRBY CITATION FOR DISTINGUISHED MASONIC SERVICE

The Ephraim Kirby Citation was established in 1944 to recognize and show appreciation to the Companion who is outstanding in his Masonry, his community and his daily vocation and who has an unusual record of loyalty, perseverance, dependability and/or courage. It is not meant to be given to those who have already received honors, but is especially intended for those who are so unselfishly devoting time and zeal to the welfare of individual Chapters and Masonry that they may be classed as the forgotten Companion. The Ephraim Kirby Citation is to ensure that such merit does not go unrewarded.

The Judges for the Citation are the Committee on Awards of the Grand Chapter. A Candidate for the Citation must be a Companion in good standing and shall not have applied himself for the Citation. Any Chapter may recommend a candidate for the Citation and the decision of the judges will be considered final. No more than one Citation for each thousand members of fraction thereof may be awarded in any one year. It should be emphasized that the award was set up to be awarded those Companions who had served their Chapters and had never been High Priest.

The Ephraim Kirby Citation for Meritorious Service is awarded for:

- Real loyalty and exceptional service to Masonry, particularly the Capitular degrees.
- Rendering, without the hope of fee or reward, unusual and outstanding service to his community, state, or nation.
- Having performed an act of heroism.

The award consists of a certificate or citation of meritorious service together with a suitable emblem of same and is presented at the Annual Convocation of the Grand Chapter or other suitable occasion by the Grand High Priest or by a Companion designated by the Grand High Priest.

#### PAUL LARSON CHELLO

#### **EPHRAIM KIRBY AWARD CITATION**

Paul Larson Chello was born on November 11, 1942, the son of Paul W. Chello, P.M. of St. Albans Lodge No. 38, and Ellen M. Johnson P.W.M. of Olive Branch Chapter No. 87, O.E.S. He has a sister, Ellen J.C. McFarland. He graduated from Guilford High School in 1960. He received a B.A. in Biological Sciences from the John Hopkins University in 1964. In 1970, he received a Ph.D. in Pharmacology from the University of Vermont College of Medicine. His doctoral thesis involved a comparative biochemical study of enzymes from mammalian and parasitic tissue to develop new targets of chemotherapy for the treatment of parasitic infections. He received a J.D. from Quinnipiac College School of Law (formerly University of Bridgeport) in 1984. Paul married Emily M. Luckert in 1988 and is the father of Ashley Margaret Chello and the stepfather of Nicholas M. Kushner. They reside in Guilford, CT.

He was an Assistant in Research (1965) and a Postdoctoral Fellow (1970-1973) at the Yale University School of Medicine, Department of Pharmacology, developing chemotherapy for the treatment of leukemia. From 1974 to 1980 he was a molecular pharmacologist at the Memorial Sloane Kettering Cancer Center and a Professor of Pharmacology in the Department of Pharmacology at the Cornell University School of Medical Sciences. While in the field of cancer research, he published over 60 papers and abstracts in national and international scientific journals. In 1980, he decided to make a career change into the practice of law. As co-owner of the Chello Oyster House in Guilford, Connecticut from 1978-1987, he attended Law School simultaneously while working at the restaurant. Following graduation from Law School, he clerked for the Superior Court of the State of Connecticut and was a principal in Chello and Sokolowski, Attorneys at Law, in Stamford, Connecticut. Following the death of his partner, Myron Sokolowski, he joined the firm of Antollino, Angelo and Scalesse, Attorneys at Law in Branford, Connecticut, with whom he practiced for several years. He opened his own practice in 2007 with offices in East Haven and in Guilford.

His professional memberships, past and present, include the American Association for Cancer Research, the New York Academy of Sciences, the American Society for Pharmacology and Experimental Therapeutics, Sigma Xi, the American Society for Cell Biology, the Connecticut Bar Association and the New Haven County Bar Association. He has been honored with the following awards: United States Public Health Service predoctoral and postdoctoral fellowships; National Defense Educational Act Title IV Fellow, and the Outstanding Legal Scholarship Award from the University of Bridgeport School of Law.

Active in his community, Paul has served on the Board of Directors of the Guilford Free Library, as a Commissioner for the Town of Guilford on

the Economic Development Commission, the Land Acquisition Commission, on two Charter Revision Commissions and on the Rollwood Farm Advisory Commission. He is currently serving as one of five Commissioners which constitute the Guilford Board of Police Commissioners, and as one of five members of the Guilford Board of Ethics. He is the Administrative Hearing Officer for Zoning Enforcement and Inland Wetlands violations for the Town of Guilford, and often is the Moderator for Guilford Town Meetings. He is a long serving member and past Chairman of the Guilford Republican Town Committee, currently its Treasurer. He is a member of the First Congregational Church of Guilford.

Paul was Raised in St. Albans Lodge No. 38, AF&AM in 1964, and served as Worshipful Master in 1974 and in 1995, earning the Master's Achievement Award in both years. He is President of the Board of Directors of the Guilford Temple Association, a position he has held for several years. He is a past President of the Fourth Masonic District Blue Lodge Council. He is a charter member of the newly formed "colonial concept" lodge, Quinta Essentia No. 500. He also served as the Judge Advocate for the Most Worshipful Grand Lodge, AF&AM of Connecticut for three terms and also served on the Grand Lodge Committee on Legal Affairs.

He was Exalted in Halleck Chapter No. 44, RAM in 1971, and served as its Most Excellent High Priest in 1976, 1986, 1991, 1994, 1999, 2000 and 2009. In intervening years he held subordinate offices. He was consecrated in the Order of High Priesthood in 1976. He was appointed Grand Custodian of the Grand Chapter of Royal Arch Masons of Connecticut in 2000 by Most Excellent Grand High Priest William L. Greene. He was appointed to the Grand Line of the Grand Chapter of Royal Arch Masons of Connecticut as Grand Master of the Third Veil in 2004 by Most Excellent Grand High Priest Robert G. Fitzgerald and progressed to election in 2010 as Most Excellent Grand High Priest, and now is a Grand Trustee.. He served as an Ambassador of the General Grand Chapter International and is a recipient of the General Grand Chapter Ritual Award. In 2011, Paul was appointed by Most Excellent General Grand High Priest Edmund Harrison to the Board of Directors of the Royal Arch Research Assistance charity. In 2013, he received the General Grand Chapter Medal in Bronze for distinguished Masonic service.

Companion Paul was Received and Greeted in Crawford Council No. 19, R&SM in 1972, and was elected Thrice Illustrious Master in 1980. He received the Thrice Illustrious Master Degree (Order of the Silver Trowel) in 1980. He is also a Charter member of Menunketuck Council No. 36, R&SM and currently serves as its Thrice Illustrious Master, an office he also held in 1992, 1993, 2001, 2002, 2005, 2006, 2008, and 2010. In other years he served in subordinate offices. He was appointed to the Grand Line of The Most Puissant Grand Council of Royal and Select Masters of Connecticut in 1996 by Most Puissant Grand Master Richard L. Small, and progressed to election in 2000 as Most Puissant Grand Master. He now

serves as Grand Trustee and as the Grand Representative of Ohio near Connecticut. He was honored as a Knight of Ish Sodi in 1995. He is past Thrice Illustrious King of the Connecticut Council of Anointed Kings and portrays the role of Adonijah on the degree team. He received the Philip J. Jones Award of the Grand Council in 2010.

Paul was knighted in New Haven Commandery No. 2, KT in 1972, served as Eminent Commander in 2006, and is now its Treasurer. He is the Grand Representative to Ohio near Connecticut. He received the Order of Knight Crusaders of the Cross in 2006. He is a member of Apostles Tabernacle No. XXVII, Holy Royal Arch Knight Templar Priests and has served as its Eminently Distinguished Preceptor. In 2010 he was appointed to the Grand Line of the Grand Commandery of Knights Templar in Connecticut by Right Eminent Grand Commander Jack H. Stevens, and subsequently served as Right Eminent Grand Commander in 2018.

He is a Companion Knight and Past Governor of the Connecticut York Rite College No. 17. He received the Order of the Purple Cross in 2007 and was created an Associate Regent of the York Rite Sovereign College of North America. He was installed as the Right Eminently Distinguished Grand Governor for Connecticut of the York Rite Sovereign College of North America in July, 2010.

Paul is a member and Past Sovereign Master of Nathan Hale Council No. 78, Allied Masonic Degrees. He was created and constituted a Knight Commander of the Red Branch of Eri and Appendant Orders. He is a Frater (VIII°) of Connecticut College, Societas Rosicruciana in Civitatibus Foederatis where he served as Celebrant for several years.

He is a Knight Companion and officer of St. Andrews Conclave, Red Cross of Constantine and Appendant Orders, and served as Puissant Sovereign.. He is a member and Past Prior of Connecticut Priory No. 28, Knights of the York Cross of Honour. He is entitled to wear the KYCH Grand Cross with three quadrants. He is a charter member of Nutmeg Chapel No. 29, Saint Thomas of Acon, and he is a member of the Royal Order of Scotland.

An active member of the Scottish Rite Bodies and Lafayette Consistory in the Valley of New Haven, Paul was Thrice Potent Master of the E.G. Storer Lodge of Perfection for two terms (2007-2009), and was Most Wise Master of the New Haven Chapter, Rose Croix, for six terms (2010-2016). He was Senior Warden of the Elm City Council, Princes of Jerusalem, and is the First Lieutenant Commander of Lafayette Consistory. He was created a Sovereign Grand Inspector General, 33°, Northern Masonic Jurisdiction on August 26, 2008.

Paul is a noble of Sphinx Temple, A.A.O.N.M.S. and a member of the Order of Eastern Star. He has served on the Board of Directors of the Masonicare Health Center and now serves on the Board of Directors of Masonicare Home Health and Hospice. He is a member and past President of the Dusis Society, a member and past President of the Twilight Club, and a past president of the York Rite Coordination Committee.

Craig R. Nelson, Sr. was born on August 31, 1947 in New Orleans, Louisiana, to Charles Nelson, Jr. of New Orleans LA and Rosalie Milas of Bridgeport CT. When he was three years old, he accompanied his parents to take up residence in Stratford CT. He attended the Stratford Schools, graduating from Stratford High School in 1965. He attended the University of Bridgeport, graduating with a Bachelor of Arts degree in Sociology in June, 1969. On July 4, 1969, he married his high school sweetheart, Virginia Ondecko. Craig and Virginia have three children, Craig, Jr. (1973), Laura (1975), Eric (1977), and four grandchildren.

Craig returned to UB as a full-time graduate assistant and graduated with a Master of Arts Degree in Sociology in September, 1970. He began teaching Middle School Math and Science in Bridgeport while returning again to UB part-time to pursue studies in Elementary Education. He graduated with a Master of Science Degree in Elementary Education in December 1972. In 1974, he began teaching elementary school in Stratford and remained there for thirty-four years until his retirement in June, 2008. From 2008 until 2013, he was an Adjunct Instructor of Mathematics at Housatonic Community College in Bridgeport CT. During his teaching years, Craig supplemented his teacher salary with many various part-time jobs. He has operated a Financial Services Business from 1984 until the present. He is also Co-owner with Virginia of C&V Nelson Properties, LLC, a real estate rental properties business, from 2007 until present.

Craig was raised as a Master Mason in Ansantawae Lodge No. 89 in Milford CT on December 4, 1981, where he served on the degree team. #### Personal

Born to Arnold Simon Grot and Olga Cynthia (Lonak) Grot on August 25, 1949 in Gary, Indiana, Arnold Stephen Grot was the 5th of 6 children in his family. He graduated from Andrean High School and went on to Purdue University, where he received a Bachelor of Science degree in Engineering Science. After a whirlwind summer romance at the University of Washington (where he took an intensive Chinese language course) he married Nancy Sarah Kleinbach in the summer of 1972 in the small wheat farming community of Connell, Washington. Two years later he was awarded a Master's degree in Metallurgical Engineering by the University of Tennessee in Knoxville.

Diploma in hand, they packed up his car and drove to Hartford CT to start a career at Pratt and Whitney in June 1974. After six months of living in an apartment on Asylum Hill, they moved to Glastonbury which they now consider their hometown.

MEP James then called upon Tres-Rec Bill for his business. Bill motioned that in the absence of any errors or omissions, the Minutes of the 170<sup>th</sup> Convention stand as printed in the 2019 Grand Chapter Proceedings. The AHPs so voted.

Tres-Rec. Bill presented his report of our last year ending March 31, 2020 which had been reviewed by AHP Michael Seamon, acting auditor, who was called upon to report that the records were well kept and accurate, commending the Tres-Rec.
