

JEFFERY A. FLYNN

Jeffery Allen Flynn was born the son of Edward and Jacquelyn Flynn on 20 January 1960 in Wethersfield, CT. He lives with his wife Peggy of 38 years in Clinton. They have a son Nick and a daughter Lisa.

Jeff graduated from Wethersfield High School in 1978, and immediately attended college, graduating Summa Cum Laude from the University of Hartford in 1982, with a degree in Philosophy and Religion, and was then Ordained as a non-denominational Christian Minister in 1982. He also won the Best Officiant Award on The Knot and Wedding Wire for many years. In addition to officiating weddings, he performs Baptisms and Funerals.

He volunteered as Coach for both boys and girls Soccer and Basketball for 10 years, starting in 1999.

In 2003, Jeff became a Volunteer for the American Lab Rescue, finding suitable and safe homes for unwanted dogs through visits with prospective families wishing to adopt, and he continues to devote time to this cause.

In 2010 he founded Christian Open Ministry, a traveling ministry. As an Ordained Minister, he provides regular worship services at assisted living facilities, and he regularly visits the sick and infirm throughout CT. He has been a Member of the Association of Clergy International for 15 years.

He served on the Board of Directors for the Property Owners of Lake Hayward in the years 2010, 2011, 2012, and 2013, and is the current President and Volunteer Property Manager for 242-246 East Main Condo Association in Clinton CT, and has been since 2010. In addition, he is the current President and Volunteer Property Manager for Maritime Knoll Professional Center, and has been since 2010.

He has over 30 years in Marketing and Advertising experience and has been a Real Estate Investor for over 25 years.

He has been a Member of Connecticut Society of Genealogists and of the Irish American Historical Society as well as the Irish American Community Center for 30 years.

MASONIC

Jeff was Raised a Master Mason on April 19, 2006, part of the first class to be raised in Estuary Lodge No. 43. While his primary lodge is Estuary Lodge No. 43 in Old Saybrook, he is also an

Affiliate of Columbia Lodge No, 25, in Glastonbury where he is currently the Junior Warden. A Past Master of Estuary Lodge No. 43, years 2010, 2011, 2013, 2014, 2016 and 2017, he is also a Past Master of Granite Lodge No. 119 for the year 2012.

Jeff served as Blue Lodge Council President for the year 2012. He was on the Grand Lodge Sessions Committee in 2012 and Co-Chairman for the year 2013. He was a District Deputy of Grand Lodge of CT, District 7B, from 2013 to 2015, and has served on the Masonicare Board of Directors for many years.

SCOTTISH RITE

Jeff is a member of the Valley of Hartford, Ancient Accepted Scottish Rite. Upon receiving his 32°, he joined the officer line of the Lodge of Perfection where he moved through the chairs to become the Thrice Potent Master for the years 2010, 2011, 2014 and 2015.

He served for many years as the Valley of Hartford's Family Life chairman and has offered many activities and trips that have bolstered fraternal fellowship, growth, and fun for both Scottish Rite members and their families.

He is the founder of the "Scottish Rite/Freemasons 5K Run/Walk to Benefit Children with Dyslexia," and was Chairman of this event for the first 5 years, raising over \$50,000. To date, this event has surpassed \$120,000.

He has been a member of the Valley of Hartford Membership Committee, since 2012 and continues to offer his skills and talents to the benefit of the Valley of Hartford members. He also served as the Valley of Hartford's Executive Council Chairman in the year 2012.

DELIBERATIONS OF THE GRAND CHAPTER

The Annual Meeting of the Grand Chapter of Royal Arch Masons of Connecticut was declared to be open by Most Excellent Grand High Priest Jeffery A. Flynn at 11:00 am on Saturday, 5 June 2021.

Companion Edward Varjabedian, in the last minute absence of RE Grand Chaplain William Weisert, was called upon to offer prayer, after which MEGHP Flynn led the Companions in the Pledge of Allegiance to the Flag of the United States of America.

MEGHP Jeffery A. Flynn extended a most cordial welcome to all companions in virtual attendance and acknowledged the presence of the following:

MEGHP Flynn called upon the Grand Secretary for the report of the 222nd Annual Convocation, for which the Grand Secretary moved the minutes of the 222nd Convocation be accepted as printed in the Proceedings and so ordered.

MEGHP Flynn recognized the group of Past Grand High Priests present today with his appreciation for their advice and counsel during his year.

MEGHP Flynn called upon the Past Grand Custodians present and thanked them for their past service.

MEGHP Flynn acknowledged the group of our Companions serving as Grand Representatives for our sister jurisdictions.

MEGHP called upon those Companions having been recognized for their service as holders of General Grand Chapter Medals. Thank you.

And lastly, our own Ephraim Kirby Meritorious Service Award winners present were called upon and recognized for their distinguished accomplishments to our communities, Masonic and otherwise.

REPORT AND ADDRESS OF THE GRAND HIGH PRIEST

MEGHP Flynn then delivered his Report and Address, receiving a "Virtual" round of applause, after which RE Grand King Luft referred it to the Committee on Address.

MEPGHP Eppler reported for the **Committee on Address** with thanks for the contributions by ME Jeffery Flynn in promoting the welfare of our Chapters in these uncertain times. The motion to accept the report was APPROVED.

REPORT SUMMARIES & REMARKS

MEPGHP Seamon, Chairman of the Committee on Audit, reported that the records of the Grand Treasurer, Grand Secretary and Grand Trustees which were supplied by electronic means had been in good order and well kept. On motion, the report was ACCEPTED.

The reports of the Grand Treasurer, Grand Trustees, and Grand Secretary were each presented in turn, and, on motion, APPROVED.

Companion James S. McNeely, having been just installed moments our session, as the new **Most Puissant Grand Master of Royal & Select Master in C**T, was called upon for his remarks. Most "Pu" James of course brought greetings from the Cryptic Masons and his own personal congratulations on ME Jeff's year.

Continuing, MEGHP Jeffery then announced his **Awards** for distinguished service: the Ephraim Kirby medal to Comp. Dale T. Cunningham from Washington Chapter 30 in Suffield, and the General Grand Chapter Medal in Bronze to Companion Robert G. Fitzgerald of Pythagoras Chapter 17 in East Hartford. Both recipients were on the call "Virtually" and surprised and humbled by these recognitions, with physical presentations coming later once we're all back together.

On behalf of Grand Chaplain Weisert who was attending to a funeral this morning, Secretary Miller gave the report of the **Committee on Necrology**, noting in particular the passing of 12 of our Past High Priests. The report and prayer was ACCEPTED (and can be found among the other reports of these proceedings).

RE Grand King Luft presented a **Budget for the Fiscal Year ending 30 April 2022** which anticipates a return to our pre-COVID state of affairs and budgeted allowances for same. On motion, the Budget and its Implementing Resolutions were ADOPTED.

RE Principal Sojourner Mike Sabia offered the **Committee Report on Ritual**, which addressed how the concluding section of our Past Master Degree has become a little too crazy and found to be superfluous and proposed an alternative ending that preserves our ancient customs. Upon his motion, his report was ACCEPTED.

RE Grand King Luft reported for the **Committee on Bylaws of Constituent Chapters** which reviewed the ByLaws prepared for Keystone Chapter 6 that incorporate Burning Bush-Washington Chapter, and finding them acceptable, and upon his motion, were ADOPTED for Keystone No. 6.

RE King Luft reported that there were NO **Delinquencies** among the Chapters which presently remain: all bills including arrearages have been paid, reports filed, and Chapters fully represented today. Upon his motion, this report was ACCEPTED.

MEGHP Flynn reporting for the Committee on Welfare of Constituent Chapters echoed the prior preparations made for the merger of Burning Bush-Washington Chapter into Keystone, making a new Chapter "Keystone No. 6" (preserving the Burning Bush number and history a bit). Upon his motion, the Companions

voted to APPROVE the merger with such documents and property to be apportioned accordingly.

MEGHP introduced the next speaker, Companion Craig R. Nelson, Right Eminent Grand Commander of the Grand Commandery of Knights Templar of Connecticut who brought his greetings to the Grand Chapter and best wishes.

Reports continued. ME McNeely then provided the report of the **Committee on Educational Awards**, recommending that the total \$5000 be divided evenly among 15 worthy applicants. On motion, the report was APPROVED.

MEPGHP Bellmore delivered the report of the **Committee on Jurisprudence** which recommended approval of the actions of MEGHP Flynn. On motion, the report was ACCEPTED.

MEGHP Flynn then ordered that all other reports not read but received be printed in the Proceedings.

Companion Teko Foley, General Grand King of the General Grand Royal Arch Masons International, and representing our General Grand High Priest Steven G. Tiner (who was on the call earlier but excused himself for another appearance), brought fraternal greetings from the General Grand Chapter and remarks in anticipation of rejoining us down the road, being no stranger to CT.

REPORTS

REPORT AND ADDRESS OF THE M. E. GRAND HIGH PRIEST

Companions,

I would like to begin by thanking Past Grand High Priest Charles O'Neill for appointing me to the Grand Chapter line. Secondly, I would like to thank our Grand Chapter Secretary and PGHP Bill Miller for all his guidance and support throughout my term. I would also like to thank Assistant Grand Chapter Secretary and PGHP James McNeely for his guidance and Zoom meetings set ups. Honestly, we couldn't have done it without you!

I would like to reflect on what happened and what didn't happen. Let's see.....I didn't hand out any pins (actually I didn't even make a pin), no ribbon cutting, photos with babies or racking up miles in travel. What happened...I kept Chapters together the best I could considering the cards we all were dealt. I attended countless Chapter zoom meetings and by the end of the week my eyes were crossed and my wrist hurt from holding my cell phone. Note, I was given a present for my birthday which was a cell phone stand for my Zoom meetings. Happy now!

I put out a call to my Grand Chapter Officers and asked them even if they were not assigned to a particular Chapter, attend and support them. Many Chapters needed Grand Chapter Officers in order for them to open. When I saw a Chapter was in trouble, I would immediately text some reliable Grand Chapter Officers and they were there for me and the Chapter. Special thank you to Past Grand High Priest James Kleinkauf for his willingness to attend Chapter meetings via Zoom. He offered, and I took him up on his gracious offer. Again, he made a difference many times whether a Chapter was able to open. I must say that I was quite disappointed with some of my Grand Chapter Officers. Not only did they not come to bat helping Chapters that they were not assigned but I hardly saw them attending Chapters they were assigned.

It was quite challenging at first for some Chapters to conduct their meetings via Zoom. It was a mystery and uncharted waters. Some Companions didn't even have a computer or smart phone. I asked, 'Do they have a phone?" That being said, after the hard work of PGHP McNeely the Chapters were up and running. ALL Chapters, with the exception of one, held regular Zoom meetings on their meeting nights! My message was "Educate and Welcome All".

I saw some great education which sprung into a spirited conversation. I witnessed the Chapters Welcome All in attendance. This was more important this year since it was not very easy for most Chapters to open even via Zoom. Welcoming all only takes a minute or two and goes a long way recognizing their effort to attend.

We did an experiment involving 3 Chapters and 3 Councils. Each Chapter and Council opened, conducted their business and closed separately. We had one Education program at the end. What happened? -- We hit it out of the park! After the education, we had a wonderful discussion and the meeting was adjourned in 1 hour! You heard that right, 3 Chapters and 3 Councils meeting separately with great education all in an hour. The meetings were efficient and well run. Best of all, they all wanted to do it again next month.

My further attendance via zoom included:

Semi-Annual Convocation of the Grand Royal Arch Chapter of Massachusetts, The Grand Royal Arch Chapter of Massachusetts, The Grand Council of R.& S.M.M. of Massachusetts, The Grand Commandery of Knights Templar and the Appendant Orders of Mass. and Rhode Island, Southwest Regional York Rite Conference, Grand Lodge A.F. & A.M. of Connecticut semi-annual, General Grand Chapter Triennial Convocation, many Commandery's Christmas and Easter Observances, Grand Lodge A.F.&A.M. of Connecticut Annual Communication, Grand Commandery of Knights Templar of Connecticut Annual Conclave, Grand York Rite Sessions of Maine and the CT Anointed High Priests Annual Convention.

General Dispensations:

I allowed Chapters to meet virtually for their stated communications. The opening and closing was modified having no ritual which included signs. This virtual meeting would count as a legal regular stated communication. No degree work would be held virtual.

With respect to the provision in Grand Chapter Law Section 206 barring a Companion from three successive terms as High Priest, a dispensation was granted to all affected Chapters that a sitting Excellent High Priest may serve a third successive term for the year 2021-2022, if he so desires and is duly elected by the will and pleasure of his Companions.

Summary of Other Dispensations:

Burning Bush Washington 6 requested on September 15, 2020 a dispensation allowing them to meet with Keystone 27 for the rest of the Capitular year. They are in the process of merging, but in the mean time, Burning Bush 6 needs the help of Keystone 27 Companions in order to open Chapter and conduct their business. A dispensation was given on the condition that Burning Bush-Washington must bring their Charter, both Chapters must open and close separately, and the Companions of Burning Bush given due and timely notice of all such meetings to be held under this dispensation. The original dispensation expired on March 1, 2021 and was extended to May 31, 2021.

<u>Trinity 9</u> requested on September 22, 2021 to meet on Tuesday September 29, 2020, reason being they could not organize a Zoom meeting in time for their regular stated communication scheduled for earlier in September. This dispensation allowed them more time to set up and notify their members with due and timely notice.

Halleck 44 requested on October 22, 2021 a dispensation allowing them to meet with Joseph Andrews - Pulaski 26 for the rest of the Capitular year (until May 31, 2021) in order for Halleck to have enough Companions to open a meeting and conduct business. A dispensation was given on the condition that Halleck must bring their Charter, both Chapters must open and close separately, and the Companions of Halleck given due and timely notice of all such meetings to be held under this dispensation.

<u>Columbia 31</u> who regularly meets the first Friday, requested March 9, 2021 to reschedule their April meeting for Friday April 23, 2021 since Good Friday fell on their usual meeting night this year. Companions having been given ample timely notice of this oddity, a dispensation was granted.

Appointments:

I nominated Michael Sabia to be the Grand Representative of Italy.

50 year presentation:

I had the utmost pleasure of presenting Companion Charles Hall his 50 year pin and certificate. We did this via Zoom but it was pony expressed to him.

Other action:

I arrested the charter of Hiram Chapter No. 1 on February 26, 2021. This action was taken as a result of a number of ongoing deficiencies of the Chapter to meet the prescribed conditions set forth in the Constitution & Law for a Chapter to be viable, notably not holding regular meetings, greeting candidates or making required reports and payments. This condition has existed over a sustained period of time, and any path to rebuilding the Chapter, even the most difficult, is not apparent. Hence, after lengthy counsel and consideration of all the factors involved, I made the difficult decision to dissolve Hiram Chapter No. 1.

In conclusion, I had a rewarding year. I did my best with the cards we ALL were dealt with. My year like many Past Grand High Priests could have involved fun traveling, ribbon cutting, free dinners and photo ops but I had the difficult task of keeping Chapters together through motivation and maybe a little push here and there. I followed the State's guidelines to the fullest. Safety for our Companions was my number one concern. When the Governor said 'no more than 10 at a private gathering' that's what we followed. Yes, we have private gatherings at private buildings. Plain and simple. I did not try to look for loop holes.

Festivals may be the answer for the Chapters to get caught up with their candidates in the wings. Whether you're a fan of festivals or not, right now it is the best way to have Chapters get back in the saddle. Finally, I wish the best of luck to my Grand King Dan Luft. If there's anything I can do, please don't hesitate to contact me.

I have very much enjoyed the support of the Companions this year and the ideas that we worked on to better the craft at labor. Looking forward I can leave with this. I will do my best to serve this Grand jurisdiction to the best of my abilities and see to the advancement of knowledge and virtue to my companions. GRAND SCRIBE

This past year has been challenging. Usually when I write a Grand Officers report I try to include my impressions of the Chapters I have visited. This was not possible this year. It is also my practice to attend as many out-of-state Grand Sessions as a can. Again, not possible this year. What we learned this year was a new word - "ZOOM." I'm certain that when the Merriam-Webster Dictionary releases their new words for 2021 there will be a new definition added for "zoom" – noun or verb – "a way to hold a meeting when the Governor prohibits in-person sessions." This year the ZOOM teleconference protocol became the de-facto procedure of Masonry meetings. With the aid of ZOOM and a few in-person meetings at the end of the year, I have participated in nearly one-hundred-thirty events. I seriously doubt I would have attended that many in-person events in a normal year. ZOOM meetings appeared to have saved, or essentially sustained Masonry throughout the pandemic.

Out of State Visitations

This year I participated in the ZOOM meetings for the Grand Sessions in Connecticut, Vermont, New Jersey, Delaware, New Hampshire, Maine, and North Carolina. I had planned to log on to the Sessions in Massachusetts, New York and Pennsylvania, but they were limited to in-state Companions and the Grand Sessions in Ohio, after being twice postponed, were finally cancelled altogether. Inexplicably the Rhode Island Grand Chapter and Grand Council Sessions were scheduled for the same weekend as our Grand Sessions. I also attended the ZOOM meetings for the Annual Convocation of the General Grand Chapter, the Annual Assembly of the General Grand Council and the General Grand Chapter and General Grand Council portions of the Northeast Department conference. Finally, I was especially pleased that I was able to attend two ZOOM meetings of my father and grandfather's York Rite Bodies in Dayton, Ohio; Mount Moriah Chapter 230 and Silver Trowel Council 141, and also the Christmas Memorial Service of Reed Commandery 6 held in the Scottish Rite Auditorium at the Dayton Masonic Center. That brought back childhood memories of attending this program with my family and two-thousand-plus guests.

State Masonic Visitations

For the major portion of this year any Masonic meetings in Connecticut were held by virtual ZOOM teleconferences. I attended four of the five Commandery Christmas Observances, the Anointed High Priests annual meeting and two Grand Chapter officers meetings. I was also able to "visit" ten of the thirteen Chapters at least once. Rittenhouse Chapter 11 and Keystone Chapter 27 meet on the same nights as my own Chapters and I was not aware of any ZOOM meetings scheduled for Trinity Chapter 9.

In October 2020 I was the only Grand Chapter officer in attendance at the postponed annual meeting of Hiram Chapter 1. This was an in-person Convocation and ten of their Companions along with eight other visitors were present. I thought that this was a successful meeting as all the reports were presented and a new High Priest was elected. They also received commitments from several of their Companions to become active in the Chapter. However I was wrong as their Charter was seized by the Grand High Priest last March.

As we arrived at September the restrictions on in-person meetings began to ease up. My Lodge, Federal 17, started holding in-person meetings in September, and even conferred the Master Mason Degree in December 2020 (in abbreviated form) and the Entered Apprentice Degree in May 2021 (in regular form). Franklin Chapter 2, Harmony Council 8, New Haven Commandery 2 and Saint Elmo Commandery 9 began holding in-person meeting in April, and in May New Haven Commandery 2 held their Annual Ascension Day Service in-person, with a dinner after the program!

Observations

With the restrictions we have been working under, it is difficult to make any concrete evaluation of the Chapters. One thing I can say is that with ZOOM meetings for many of the Chapters, participation by Grand Chapter officers and other visitors was necessary to have nine Companions present. Before you look at this lack of active participants in a negative light, one should remember that not all Companions might not have access to a computer or be interested in participating by ZOOM. During the pandemic many of the Companions have been working from home and communicating with their co-workers daily by ZOOM, and some of them found it hard to log on in the evening to another ZOOM Masonic meeting.

One of the primary benefits of ZOOM is the ability to connect with out-of-state Companions and those who for health reasons or other conflicts are not able to attend in-person meetings. Some of these Companions have been the most loyal participants. The ZOOM meetings also allowed for increased participation by the Grand Officers and other visitors. This is a change from the usual routine of having only the Inspecting Grand Officer or the Most Excellent Grand High Priest visiting the Chapter. Hopefully this increased participation by the Grand Chapter will continue to occur in the future.

Finally, after having used ZOOM to connect with some of our "lost" Companions, what happens to them as we begin to return to in-person meetings? As I said before, in many instances these Companions have been our most loyal participants, and now suddenly they will be losing their method of communications. How do we prevent this? There are two possible ways to keep these Companions participating. In the first case, the Chapters could continue to designate one or two meetings a year as a hybrid Convocation, and conduct these meetings by ZOOM. This would most likely require a dispensation from the Grand High Priest, or at least an edict from him allowing the same. The second idea would be to occasionally call a special meeting by ZOOM for the sole purpose of social communication with those Companions. The Companions of Franklin Chapter 2 and Harmony Council 8 have discussed the second possibility and will probably combine to hold some special meetings next year.

I look forward to my service as Right Excellent Grand King in the coming year, and to the hope that our Masonic activities can return to normal.

GRAND SECRETARY

I stand before you now as proof that I have survived not only COVID and my first year as Grand Recorder, but my first year as your new Grand Secretary as well, but not without a lot of help and training, the largest coming from my predecessor and mentor, dearest Brother and life friend, Charles Fowler, to whom I can only express my deepest gratitude. This is not to say I am now the expert in all these matters, but my dining and living rooms would attest otherwise. Clearly this is still a transitional process and in taking this on, I had one main goal, namely to simplify as much of the process as I can along the way, as well as depend more upon the good work of others. To this end, this first year was arranged so that the Office of Secretary (and Grand Recorder) would be performed by a "team" as it were: ME James McNeely assisting from his Zoom and REGC perches with communications and scheduling matters, and the new "Retiree" Chuck mothering his Access Data base, his legacy creation, to field all those pesky monthly reports and contained data. That's his sports car and I do not have the "keys" just yet as it is too fast for me, but am permitted small trips up the street for bread. That has left me to answer the phone and emails, assist Chapters and you Companions who ask for assistance, and serve our MEGHP Jeff, as we navigated the COVID and faced some serious issues affecting our Companions in CT, and those in Council and Commandery. I was pleased to help our newer Secretaries in the finer points of their jobs and our rules, as well as a few veterans along the way. My appreciations to them all.

This has NOT been a routine year in any manner of speaking, and we are facing some serious situations which affect the whole of our CT York Rite. The difficult news begins with the statistical summary which appears along with this report. It goes without saying (but I will anyway), this year our membership tanked. The COVID precluded any ability to exalt new Companions, hence none to feed Council and Commandery. If one has ever heard the saying that the purpose of a Lodge is to make Masons, then our Royal Arch, which is the doorway to the York Rite, was basically closed and making new Companions impossible. This is not to say that Chapters haven't been gathering in petitioners, as they eagerly await a return to the quarries en-masse. From a Grand Chapter level, our MEGHP has also walked the thin line to assure the COVID mandates from on high were and are followed, but

Chapters given maximum flexibility to utilize the virtual work space to keep their Companions engaged, including a general dispensation that High Priests may, if elected, serve a third consecutive term.

From a loss standpoint, it is not apparent that the COVID effect "medically" was as bad as we may have feared, over and above the usual Lodge losses, Chapter deaths, NPDs and dimits which we have become accustomed to in recent years. We started with 979 Companions and ended March 31, 2021 with 872, a net loss of 107. If one adds back in the average 30-40 or more new Companions we have seen in any given year, the end result would actually be comparable and not be all that bad. Buried in this is the tougher statistic, namely the loss of 87 of our paying members (per capita) and resulting reduction in our income (\$1,566) and this information has been factored into the new Budget. In short, we can only hope for some kind of a surge once we can resume regular work.

But the story does not end here, as you will see in the details of the Chapter by Chapter returns. In fact, it is not rosy. There are are several elephants in the room which bode uncertain futures for all of us. First, chapter viability, especially among the weaker ones, has seen the loss of Hiram 1, and Halleck barely hanging on (they did settle up their arrearages from last year and though last, did get this year's annual return done well enough with payment so they can be considered clear, with no fines recommended for their reports.)

But we have in recent years seen a rash of mergers... last year with Joseph Andrews and Pulaski, and this year Burning Bush appears to be next. So as long as this is an off ramp for weaker chapters, we haven't lost all of their Companions yet.

But the real tough story lies in the details of their annual returns which shows a serious lack of succession capability...if a dedicated working Companion is lost (death, inability to serve, moving away), there is no one to fill the void. A quick list of how bizarre this is, groups are re-electing Companions to the East who are in rest homes; Treasurers are important, their loss in some cases has triggered probate; a new Secretary is making plans to move, and my favorite: there are 3 Companions holding down 10, yes ten Tres-Secretary-Recorder jobs...where are the 10 new Companions coming from to replace them? To help address our lack of succession planning, I have prepared a missal on this very

topic with recommendations based on our annual returns for our local and Grand Officers to study.

I have had the pleasure to work with our Grand Treasurer Charles McCollum, to whom I have turned over \$ 25,631.11 in receipts gathered in and deposited for the fiscal year ending April 30, 2021, consisting mostly of per-capita from Chapters, a regular Grand Trustee transfer, and an additional \$1,000 refunded from the Sheraton 4 Points to close our contractual arrangement with them, for now anyway. On the expense side, I issued vouchers totaling \$ 24,894.31 for payment of regular budget obligations, including a few special donations approved in the course of the year.

In closing, it has been an honor to have served the Grand Chapter in this new capacity and with your continued support, guidance and inspiration, we can only move forward.

The Combined Trust Portfolio of the Grand Chapter is invested with RBC Wealth Management through our financial advisor, Mr. Dennis Stanek. RBC has been extremely diligent during these difficult market times and has provided monthly statements and weekly updates on our investments and market trends.

The starting balance of the portfolio on April 30, 2020 was \$716,883.73. During the last year, due to volatility in the market, we have continued to reallocate our investments at the recommendation of our portfolio manager. These market fluctuations and re-investment resulted in an ending balance of \$836,703.78. We managed to make a gain of \$119,820.05, even after taking a distribution of \$5,000.00.

The physical inventory and properties of the Grand Chapter are in the custody of the Grand Secretary, the Grand Officers (aprons and jewels), and the Past Grand High Priests (jewels). Aprons, Officers' Jewels, and Past Grand High Priests' Jewels are the property of the Grand Chapter and are to be returned to the Grand Secretary when the term of office has expired or upon the companion's passing.

RESOLUTIONS CONCERNING 2021-2022 BUDGET

The amount designated in the budget as Grand High Priest Travel Reimbursement is intended for reimbursement to the Grand High Priest to offset the cost of visiting Annual Convocations of Grand Chapters in the Northeastern United States and Eastern Canada, as well as the Northeastern York Rite Conference and the General Grand Chapter Triennial. Receipts or other supporting data must be presented to the Grand Secretary to obtain reimbursement. Mileage reimbursement shall be at the rate of \$0.57 per mile for out of state travel for automobile travel, plus tolls and parking.

COMMITTEE ON INSURANCE

The General Liability policy providing coverage for the York Rite bodies of CT has a primary policy with a \$1,000,000 limit of liability with an excess policy providing an additional \$1,000,000. The non-owned auto coverage provides \$1,000,000 excess of the vehicle owner's underlying policy. Coverage for damage to rented locations such as Masonic Temple Corporations is \$100,000. Medical payment coverage is limited to \$10,000 per person. Other sub-limits include:

A separate Umbrella Policy provides a \$2,000,000 Limit in excess of the above primary policy for Commercial General Liability (CGL) coverage only. These policies are written by the Philadelphia Insurance Company through the Auburn Insurance Agency (AIA) in Massachusetts. They specialize in handling various Masonic programs. (In October of 2020, AIA was acquired by the insurance operations of Eastern Bank.)

The premium charged for these policies is apportioned between the Grand bodies based on membership at the beginning of the policy year. Grand Chapter pays the entire premium and is reimbursed by Grand Council and Grand Commandery. One member Chapter of the Grand Chapter chooses to insure their paraphernalia and reimburses the Grand Chapter for the cost.

This appears to be an equitable basis for premium sharing as the cost of insurance protection/coverage should reflect the total involved time of individual Companions and Sir Knights. At our request we had changed the annual renewal date of the coverage in order to be able to utilize the current membership reports from the bodies. The new renewal date became June 24 as a result.

AIA/Eastern Bank have a proprietary set of endorsements with the PIC for Masonic business. This sets them apart from anyone else placing Masonic business with PIC or other companies. In addition, as of late, we have been informed that there have been a number of companies which have decided to exit the fraternal business and the AIA has been picking up additional accounts as a result.

In Connecticut they handle the Grand Lodge of Connecticut, the CT constituent Lodge Masonic Temple Corporations (which choose to have them do so) and the York Masons Hall Corporation in East Hartford.

Your committee, working with the AIA, had been looking into the purchase of Directors & Officers (D&O) insurance coverage for each of the three Bodies. This type coverage, written by the Great American Insurance Company (GA), is for the purpose of protecting those serving in executive positions (i.e. Line Officers) in each Grand York Rite body from any lawsuits filed against them for "alleged injury" arising out the performance of their duties. It also provides coverage for the respective Grand Body Corporations. Without such insurance, the personal assets of those serving as officers are at risk.

While officers and directors of not-for-profit entities are exempt from liability under both state and federal law, in our litigious society, this would not prevent a party from alleging injury and filing suit. Until a court of competent jurisdiction makes a ruling on the applicability of the exemption laws, or if the court decides that the exemption does not apply to the case under consideration, there are legal expenses to be paid. This insurance provides coverage for those legal expenses.

In consequence of considering the three (3) proposals for the three Grand Bodies and the authority of them, coverage was bound effective June 24, 2020 (for Grand Chapter and Grand Council) and earlier in(May, 2020) for Grand Commandery (its Annual Meeting having taken place in April.)

For this kind of coverage, each of the Bodies must make their own decision and purchase their own policy. Each is separately invoiced for the premium for their policy.

As a consequence of the acceptance of the D&O proposals for Grand Chapter and Grand Council, coverage was bound for them as of June 24, 2020. In order to make renewal activity simpler, the Primary and Umbrella policies of the Philadelphia Insurance Company were extended to expire on June 24 also.

For the renewal of these policies (both CGL and D&O), the premium change is modest - less than \$25 per policy. This is subject to adjustment based on our up-to-date membership count. As membership has declined somewhat, this should not have a positive impact on the final premium calculation.

We recommend that the renewal be finalized with the same insurance carriers.

COMMITTEE ON JURISPRUDENCE

The Committee has reviewed the Address of the Most Excellent Grand High Priest, Companion Jeffery A. Flynn, and recommends its publication in the Proceedings of the 223rd Annual Convocation of the Grand Chapter of Connecticut.

The Committee did not receive reports from any of the subordinate Grand Chapter Officers and would remind the incoming Officers of the value associated with these reports for the incoming Most Excellent Grand High Priest as he begins his year.

Dispensations and Appointments

The Dispensations have been reviewed by the Committee and are consistent with Grand Chapter Law and practice. His appointments are within his authority and are also consistent with the Law and practice. We also concur with his general dispensations permitting virtual communications and allowing a sitting Excellent High Priest to serve three consecutive terms, given the state of the health emergency and subsequent governmental edicts.

Pending Legislation

There is no pending legislation on the table and no new legislation has been received.

Request for Change to the Constitution regarding Ritual

The Committee received a request for a change to the Constitution to modify the Past Master Degree. Under Section 114.13, the Ritual Committee has the authority to recommend changes to the Ritual Work which must be approved by vote of the Grand Chapter. In addition, Section 600 states, "The Standard Work of this Grand Chapter shall be as recommended by the Committee on Ritual and adopted by the Grand Chapter." This change simply requires a vote of the Grand Chapter at its Annual Convocation and does not require a change to either the Law or Constitution.

Hiram Chapter No.1

The forfeiture and arrest of a Charter of any Constituent Chapter is not a step that should be taken lightly by the Grand Chapter or by the Most Excellent Grand High Priest. The Most Excellent Grand High Priest, acting on the report of the Grand Chapter Officer assigned to Hiram Chapter No. 1, and historical information provided by the Grand Secretary, after consultation

with the subordinate Grand Chapter Officers and several Past Grand High Priests, arrested the Charter of Hiram Chapter No. 1 on February 26, 2021. This action was within his prerogatives under Section 204 of the Grand Chapter Law.

A letter was subsequently received by the Committee from the Companions of Hiram Chapter addressing several grievances with the process. The grievances included that they were not afforded a meeting with the Most Excellent Grand High Priest to address what they feel are discrepancies in the information his decision was based upon, and they feel that they were not given an opportunity to express their concerns. When this Committee recommended a meeting to the Most Excellent Grand High Priest he again declined.

Additionally, they were not assigned to another Chapter, as is normal practice when a Charter is surrendered or arrested, but instead were issued dimits with a letter stating they must affiliate with a Chapter prior to May 31, 2021, or they would lose their membership. Section 307 provides that a dimit be granted to a Companion in good standing without any requirement regarding a time limit for affiliation.

Hiram Chapter No. 1 has struggled for many years to be in compliance with the Grand Chapter Constitution and Laws as the historical information provided by the Grand Secretary has established. The fervent attachment to this Chapter by the remaining Companions, who have contacted this Committee frequently to air their grievances, while compelling, does not alter the facts.

It is our recommendation that the matter be referred to the incoming Most Excellent Grand High Priest for final resolution.

We further recommend that he meet with the interested Companions, explain their viable options, if any, and determine a path forward. Hiram Chapter No. 1 is the oldest Royal Arch Chapter in Connecticut and the third oldest Chapter in this country.

It behooves us to find a way to preserve that history.

Committee Report Summary

No one could have imagined the Capitular year that our Most Excellent Grand High Priest had to encounter. Every Companion elected to the highest office in the gift of the Grand Chapter brings his plans, programs, and ideas for the betterment of the Companions of this jurisdiction. Unfortunately, the COVID pandemic derailed most of these plans.

We commend the Most Excellent Grand High Priest, Companion Jeffery A. Flynn, for his efforts to preserve the work of Capitular Masonry in Connecticut and keep Chapters meeting virtually as in-person meetings were not permitted or severely limited by government mandates and for his efforts to use this virtual opportunity to promote York Rite Education. He and his Officers attended many of these meetings to ensure that there were enough to open and the Constituent Chapters will always be indebted for your timely assistance.

The result was that Chapters would be able to work the Mark Master, Past Master (Virtual) and Most Excellent Master Degrees, but not the Royal Arch Degree. Also, several modifications that helped with social distancing were

implemented as they were disseminated to the Ex. High Priests and Secretaries of the Chapters by the Grand Secretary. Chapters were also not to be permitted to do ritual via a Hybrid format.

This Committee also had discussion regarding the Past Master (Virtual) Degree as it is utilized in Connecticut Chapters. With some deeming it unnecessary, and others wanting it retained due to tradition, we sought the common ground of making modifications that we feel will improve the work of this degree while still retaining a level of mystery from the work of the Actual Degree used in Blue Lodges. We therefore make the following recommendation to the Grand Chapter in Session:

Whereas the General Grand Chapter of Royal Arch Masons adopted a resolution in 1856 "to abridge the ceremonies now conferred in the Past Master's Degree within the narrowest constitutional limits, only retaining the inducting of the candidate into the Oriental Chair, and communicating the means of recognition;"

And whereas the portion of the ritual known as "the confusion" is many times utilized in a manner contrary to its purpose in Connecticut Chapters;

And whereas the American tradition to take the Royal Arch Degree is to have candidates "pass the Chair" to satisfy the requirement of being a Past Master to take this Most Sublime Degree;

And whereas the Past Master Degree is utilized by the Blue Lodge to invest important lessons to an Actual Worshipful Master in the Chair to maintain harmony and to be ever conscious of his duties to his Lodge;

And whereas to maintain those mysteries of "the confusion" to not take away from the experience of those elected to Worshipful Master in the Blue Lodge;

Now, therefore, be it Resolved: That the Past Master Degree be changed to exclude the portion after the RWM directs the newly installed Master to seat the Lodge after he receives the Honors (due guard and sign of PM three times), and resuming the Degree where the following direction is given: "(Appear anxious to close the lodge without the regular form)."

COMMITTEE ON ROYAL ARCH RESEARCH ASSISTANCE

Royal Arch Research Assistance, Inc. is a Foundation established in the 1970's by the General Grand Chapter of Royal Arch Masons International. As of March 31, 2021, the Companions of Connecticut have donated a total of \$42,502.92 to Royal Arch Research Assistance, Inc. since its inception. The total donated in 2020 was \$744.00. This year the donations through March 31, 2021 total \$599.95.

COMMITTEE ON WELFARE OF CONSTITUENT CHAPTERS

On February 26, 2021 the Charter of Hiram 1 was arrested. This action was taken as a result of a number of ongoing deficiencies of the Chapter to meet the prescribed conditions set forth in the Constitution & Law for a Chapter to be viable, notably not holding regular meetings, greeting candidates or making required reports and payments. This condition has existed over a sustained period of time, and any path to rebuilding the Chapter, even the most difficult, is not apparent. Hence, after lengthy counsel and consideration of all the factors involved, MEGHP Flynn made the difficult decision to dissolve Hiram Chapter No. 1.

Burning Bush-Washington Chapter 6 has essentially completed work for their merger with Keystone Chapter 27. Halleck 44 is working with Franklin 2 on a possible merger.

Succession planning remains a high priority. We are running out of officers and backups. Chapters are doing what they can, new members will help but this is a slow process.

General dispensation was given to allow High Priests to repeat

for a third year if needed to ride through the COVID crises.

Our recommendation looking forward to fall would be to keep Virtual meetings in the mix. Many companions that were out of state or homebound made a huge difference on whether their Chapter could open or not. Festivals seem to be a feasible way for Chapters to play catch up with their candidates in waiting.

Three nominations may be made during a Triennium from each jurisdiction, but only one will be presented during each Triennium to a Royal Arch Mason of one of the affiliated Grand Jurisdictions of each York Rite Region. Not More than three such Silver Medals also may be presented at the Triennial Convocation from selection at large.

General Grand Chapter RAM Intl Medal in Bronze

Robert George Fitzgerald was born on April 16, 1935 at Cooley Dickenson Hospital in Northampton, Massachusetts. He is the second son of Gertrude L. and John Aloysious. Fitzgerald, who lived in nearby Amherst. Paternal and Masonic Brother John Maurice is twelve years older.

Along with the normal "getting into trouble" activities of any youth, Bob was a Cub Scout and a Boy Scout for long enough to attain the rank of Eagle Scout. He spent a lot of time at summer camp (Boy Scout and Church related) in the summer, as both parents worked. Early on he was a camper, later a counselor.

After completing High School, Bob attended the University of Massachusetts at Amherst graduating with a Bachelors Degree in Chemical Engineering. While there he met and married Nancy Jean Campbell. They have been married 51 years as of May, 2009. They have 5 children and helped raise one foster son. Nancy retired in 2002 as Executive Director of the East Hartford Branch, YMCA. Unfortunately, Nancy succumbed to cancer in 2011.

Following university graduation, Bob took a position as a field loss prevention engineer with the Factory Insurance Association (now Industrial Risk Insurers). Initially assigned to the Philadelphia area, the Fitzgeralds resided in Harrisburg, Pennsylvania and Buffalo, New York. In 1964, Bob was transferred to the Home Office in Hartford. He retired in 1998 on the completion of 40 years of service, as Assistant Vice President of Underwriting.

Bob served as president of the South Grammar School PTA and as an officer in the Penney High School PTO, in East Hartford.

At South Congregational Church of East Hartford, (UCC), Bob sings in the choir, serves as Choir Treasurer and Assistant Church Treasurer. Other activities have included multiple terms on the Board of Deacons, chairing it for two years, several stints on the Board of Stewardship & Enlistment, chairing it for several years, chairing one Pastoral Search Committee and serving on another, and election to two separate terms thirteen years apart as Moderator. He serves as a lay reader on a regular basis.

Bob also participates in tournament Cribbage play, and has achieved the rank of Master in the American Cribbage Congress,

an international organization of serious "It's not a matter of life or death; it's more important than that!" players.

As a member of Orient Lodge No. 62 in East Hartford, he was Secretary of the Lodge for all but 3 of the years since he was raised in 1974. He was elected Jr. and Sr. Warden and then Worshipful Master for 1979. Orient Lodge is now a part of Columbia Lodge No. 25 in South Glastonbury. When Orient Lodge was sponsor of Charter Oak Chapter Order of DeMolay, Bob served as an Advisory Board Member from 1984 to 1989 and as Chairman in 1987-88.

Since 1980, Bob was Secretary/Treasurer of the East Side Past Masters' Assn., comprised of Lodges No. 25, 62, 73 and 114, and served as Rt. Worshipful Master in 1988. They are now a part of the Hartford County Lodge of Actual Past Masters.

After serving as Deputy Grand Secretary for two years, he was installed on March 31, 2004 as Right Worshipful Grand Secretary of the Most Worshipful Grand Lodge, A.F.&A.M. of Connecticut.

Bob is also active in the York Rite Masonic Bodies which meet in East Hartford. In Pythagoras Chapter No. 17, Royal Arch Masons, he served as Most Excellent High Priest in 1989, 1997 and 1998 and is currently a Trustee. In Wolcott Council No. 1, Royal & Select Masters, Bob served as Thrice Illustrious Master in 1988, and has been Treasurer since 1989.

He received the Orders of Knighthood in Washington Commandery No. 1, Knights Templar, East Hartford.

He is a Past Most Excellent President of the Connecticut Convention of Anointed High Priests in Royal Arch Masonry, and is a member of the Connecticut Council of Anointed Kings and also Connecticut York Rite College No. 17.

In May, 1999, at the One day ceremonial, Bob became a member of the Valley of Hartford, A. A. S. R. and Sphinx Temple, A. A. O. N. M. S.

EPHRAIM KIRBY CITATION FOR DISTINGUISHED MASONIC SERVICE

The Ephraim Kirby Citation was established in 1944 to recognize and show appreciation to the Companion who is outstanding in his Masonry, his community and his daily vocation and who has an unusual record of loyalty, perseverance, dependability and/or courage. It is not meant to be given to those who have already received honors, but is especially intended for those who are so unselfishly devoting time and zeal to the welfare of individual Chapters and Masonry that they may be classed as the forgotten Companion. The Ephraim Kirby Citation is to ensure that such merit does not go unrewarded.

The Judges for the Citation are the Committee on Awards of the Grand Chapter. A Candidate for the Citation must be a Companion in good standing and shall not have applied himself for the Citation. Any Chapter may recommend a candidate for the Citation and the decision of the judges will be considered final. No more than one Citation for each thousand members of fraction thereof may be awarded in any one year. It should be emphasized that the award was set up to be awarded those Companions who had served their Chapters and had never been High Priest.

The Ephraim Kirby Citation for Meritorious Service is awarded for:

- ► Real loyalty and exceptional service to Masonry, particularly the Capitular degrees.
- ► Rendering, without the hope of fee or reward, unusual and outstanding service to his community, state, or nation.
- ► Having performed an act of heroism.

The award consists of a certificate or citation of meritorious service together with a suitable emblem of same and is presented at the Annual Convocation of the Grand Chapter or other suitable occasion by the Grand High Priest or by a Companion designated by the Grand High Priest.

172nd ANNUAL CONVENTION

Most Excellent President Jason welcomed the Companion AHPs and led us in a pledge of allegiance; and Chaplain Mike Seamon offered an opening prayer. Rec Bill noted he had received regrets from AHPs Bob Fitzgerald, Bill Weisert, Richard Jones, and Richard Allen.

MEP Jason noted that since we once again cannot receive candidates, today would be devoted to the annual business and preparations for when we can expect to return to work.

MEP Jason next turned to TresRec Bill to assist with the business of the Convention, starting with a few formalities, and recognition of the Companions: first and foremost among them, our MEGHP Jeffery Flynn of the Grand Chapter who was "virtually" received. MEP recognized the other Grand Officers of the Grand Chapter: GrKing Daniel Luft, GrScribe Clyde Kayser, GrCOH Mike Seamon, GrPS Mike Savia, and himself GrRAC Jason Rieger.

MEP acknowledged Past Grand High Priests James McNeely, James Kleinkauf, Charles Fowler (Hon), William Miller, William Lott and Stephen Piner.

MEP Welcomed his officers of the Convvention (as at the opening, listed above).

MEP added the Past Presidents of the Convention present: James McNeely, Martin Ede, William Miller, Clyde Kayser, and Stephen Piner.

MEP also welcomed our York Rite leaders MI Martin Ede, Most Puissant Grand Master of the Grand Council and SK Craig Nelson, RE Grand Commander of the Grand Commandery Knights Templar.

Then came the time for our extra special recognitions. The oldest date of anointing award is a TIE, going to both Steve Piner and Bill Lott, in the same class of 1977 no less. The oldest by age is Charles Fowler, born 1937. The farthest away award goes to Steve Piner (FL) with Bill Lott next closest (DE).

Chaplain Mike Seamon presented the necrology report of our departed Excellent Companions, after which he led the Companions in prayer for their eternal service and memory. It is to be noted that among these, we lost 2 Past Presidents, Bard Teigen, instrumental in molding the current ritual we now use, and Doug Gray, who served a stint as TresRec back when. Also, PP Ken Marvin is known to be in a rest home in the Quiet Corner.

Closing announcements included:

GrScribe Clyde reported that the Order of Silver Trowel (Council TIM Chair Degree) is scheduled right now for July 13 in Meriden with a new cast and air conditioning. Hooray.

GrKing Dan said plans are being formulated for one or more 1-day festivals in the October time frame, as a combined Chapter-Council event, with degree teams assembled from our Chapter-Council ritualists.

GrSec Bill Reported the Grand Sessions are 3 weeks away and Virtual registration is now open and required even if one is expected to be in person at Meriden. Those not yet registered needing some help to do so should purt up their hands. (Some did).

MEP Jason called upon MEGHP Jeffery for final remarks bring WFG and his own on behalf of the Grand Chapter. He reflected on his year, and while there is no doubt of the value and necessity for us to return to meetings in person, he lamented that we should still try to be virtually connected with those Companions whom we haven't seen, and would stand to lose from the "Virtual" sidelines if we can't keep that service in some fashion. He thank MEP and the Companions for their efforts and looked forward to seeing them again at our Virtual Grand Convocation in 3 weeks hence.
