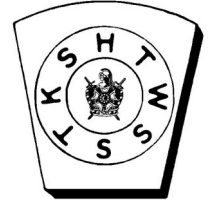

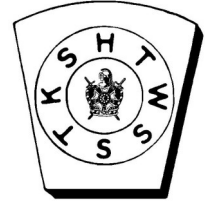
REPORT OF THE COMMITTEE
