Before advancement to the IV^o, one must attend a minimum of two (2) meetings in one's home Assemblage after receiving the III^o

ADVANCEMENT TO THE V^o AND VI^o

The V (and VI) are conferred by the Region, usually at the Annual Regional Meeting held during Masonic Week. Although the language used in some of the Society's publications may suggest that advancement to the V (or VI) is by application, advancement to the V (and VI) is by recommendation of the Assemblage's DMM and approval of the DGMM of the Region. Attendance is the minimum requirement for approval, but not the sole qualification. The number of V and VI members in each Assemblage is limited. Recommendations, Form R5 for the V and Form R6 for the VI, can be submitted at any time; however, they are usually submitted by 31-Oct for the following February conferral at the Annual Regional Meeting held during Masonic Week. Recommendations submitted after 31-Oct are usually held for the following Regional Annual Meeting. Approved candidates for Advancement are usually informed by 31-Dec.
