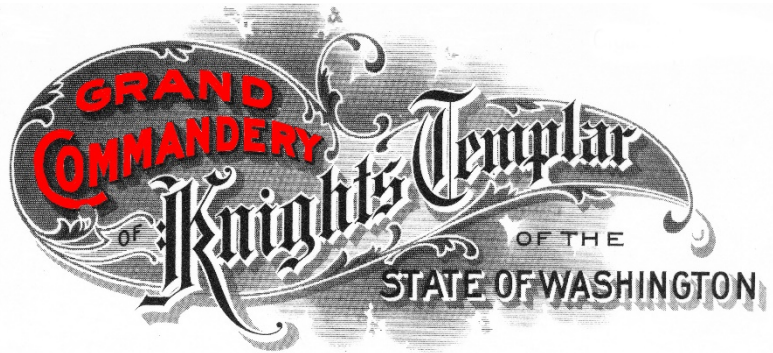

GENERAL ORDER No. 1

May 14, 2022
